

# TURKEY CREEK RANCH CLAY SHOOTING RANGE





In consideration for receiving permission from Turkey Creek Ranch (TCR) to use their facilities an equipment and to participate in any way in TCR clay shooting activities such as, but not limited to, daily use, observation, clinics, tournaments, league, camps, and special events. I understand that there are various risks involved with my participation in shooting activities at the Turkey Creek Ranch's Clay Shooting Range (hereinafter referred to as "the Range"). I understand that those risks include, but are not limited to, injuries or death caused by the following: gunshot; the negligence of other participants in the vicinity; faulty equipment, firearms or ammunition provided by myself or other participants; lighting conditions; weather; excessive noise; excessive distance to medical care facilities; and excessive traffic on routes to medical care facilities. I agree that, prior to participating in these activities, I will inspect facilities and equipment and, if I believe any are unsafe, I will immediately advise an employee of the Range. I willingly agree to comply with the stated and customary terms and conditions for participation. I am fully aware of risks and hazards connected with being on the premises and participating in these types of activities, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in these types of activities, and I hereby elect to voluntarily enter upon the above named premises and engage in these activities knowing that conditions may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risk of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my participation in these activities, whether caused by the negligence of myself, other participants or otherwise.

I also understand and agree that by signing this form, I am knowingly releasing, holding harmless, and agreeing to indemnify the TCR, Directorate of Family, Morale, Welfare and Recreation, Fort Carson, the Department of the Army, and the United States, and their respective officers, agents, employees, contractors, and employees of those contractors, from any and all liability or costs, including attorney fees, for any claims, demands, injuries, damages, actions, or causes of action associated with or arising from my use of TCR facilities and equipment and my participation in shooting activities.

My signature on this form is to bind not only me, but also my heirs, assigns, executors, administrators, personal representatives, and derivative claimants.

**Equipment Rental Clause:** If I am renting or borrowing any equipment from TCR I agree that once in my possession that I am fully responsible for all damages resulting from any negligence, loss of, or theft of the equipment issued. I agree that I maintain this responsibility until I have personally turned in each piece of issued equipment to an authorized employee of TCR.
